Benefits to Having a Permanent Court time:

1. A Court is **YOURS** every week at the same time – no last minute scramble to get a reservation!
2. You get to select who you would like to play tennis with each week. A great way to develop acquaintances into **FRIENDS**.
3. You **SAVE MONEY** by taking the court for the whole season. The rates can be \$3-\$10.00 less per hour than unreserved time.
4. **ADD A PRO** to create your own private drill once a week, once a month or whatever fits your schedule.
5. Can't make your scheduled time? Call OBRFC and we will put your court up for sale. **Notify** us ahead of time so we can sell your court. If we sell the court we will credit your group for the amount that we sold it for.
6. NEW for 2008-2009 Season: M-F, 6:00am-9:00am Perm Time - \$20.00 per hour!

Perm Court Time Renewals:

In order to reserve your court time for the upcoming season, please do the following:

1. The Group determines a Captain. The Captain will be responsible for answering all questions. Members are responsible for the entire season.
2. Captains are responsible for filling out the enclosed application and returning it to the Club. Please check "renewal of existing time".
3. Captain's must submit all names of players by **August 1st** and update bookkeeping of any changes.
4. All players listed on your application must be Club Members on or before their perm-time begins. **NO exceptions.** All subs must be Club Members.
5. New Members may be added during the season. Members may not be released during the season – see application.
6. All Groups will be split equally unless the Captain has indicated otherwise by August 1, 2008.
7. A \$75.00 nonrefundable deposit is required at the time of application and will be charged to the Captain unless directed otherwise.
8. **You may renew and guarantee your current time through April 21, 2008. At that time new applications and court programming will be considered.**

New Perm Court Time Reservations:

If you are interested in a new court day or time, please follow the same steps as above. Be sure to check the box "Application for New Time." Captains, please submit as soon as possible.

New Perm Court Times will be considered after May 1, 2008 Members on the waiting list and new applicants will be notified after May 15th regarding the available court times for the season.

Perm Time Billing Permanent court time is a contract for the season that is billed in 2 installments. It is split between players, per direction of the Captain with each Member being billed on September's bill and on January's bill. The Captain assumes responsibility for the billing. If you lose a player, you will need to replace that player or rearrange the player split.
